GENERAL INFORMATION

PCT | Sunrise BioBuild™ C-Green Amino+ II is a seaweed extract fortified with N-amino acids + a soil penetrating agent to help plants mitigate stress created by hot/dry or cool/wet condition. Seaweed extracts contain natural plant-growth hormones. Organic acids hold onto the plant-growth hormones and amplify their effects on plants. The soil penetrating agent holds the seaweed extract, organic acids and amino acids in the soil profile available to the plant and not lost through the soil with water leachate.
