RECOMMENDATIONS FOR USE

Apply as a foliar fertilizer to soybean between V2 and V5 at 2 gallons per acre. FolrFeed[®] Soy Foliar EXTRA II can be tank-mixed with most herbicides, fungicides, or insecticides, although a jar test is recommended. Total spray volume of 10 – 15 gallons per acre is recommended for best coverage. Do not apply if air temperature is greater than 85°F or in noontday sun.

GENERAL INFORMATION

PCT | Sunrise FolrFeed[®] Soy Foliar EXTRA II is a liquid foliar fertilizer with nitrogen, phosphorus, and potassium, designed to complement nitrogen fixation by nodules and apply potassium during early-season drought. FolrFeed[®] Soy Foliar EXTRA II contains boron and manganese, designed to maintain rapid vegetative growth while promoting stem branching and flower development. Boron supports sugar movement while manganese activates enzymes activation and synthesizes chlorophyll. Plant growth regulators may be added to FolrFeed[®] Soy Foliar EXTRA II to promote branching and flower retention. Manganese is dual-chelated for maximum protection against tie-up and incompatibility with other tank ingredients (herbicides, insecticides, etc.)

HANDLING AND STORAGE

FolrFeed[®] Soy Foliar EXTRA II is a mildly corrosive liquid fertilizer and should be handled and used in accordance with state, local and federal regulations where applicable. Materials and methods of construction selected for storage and handling should be those recommended by qualified manufacturers, associations, or recognized testing laboratories. Type 304 or 316 stainless steel, polyolefins, fiberglass, reinforced plastics, polyvinyl chloride, polypropylene, polyethylene-applied coatings and rubber linings are generally suitable for storage and handling of mixed liquids. Aluminum, brass, copper, zinc and many alloys, especially those of copper base, are unsuitable for use in storing and handling mixed liquid fertilizers and must be avoided. Rinse and flush thoroughly before retiring equipment for the season.
