GENERAL INFORMATION

PCT | Sunrise FolrFeed® Alfalfa Foliar is a balanced foliar fertilizer that promotes more vigorous regrowth after each cutting. Alfalfa root systems are robbed of carbohydrates and temporarily decline after each cutting, reducing the ability of soil-based fertilizers to maximize regrowth. FolrFeed® Alfalfa Foliar bypasses the soil and root systems and delivers nutrients right where they are needed for regrowth – the top of the plant. FolrFeed® Alfalfa Foliar contains both macro and micronutrients for more complete nutrition during this period. Boron during this period improves cell wall strength and disease resistance. Both boron and potassium are important to sugar movement to new tissues. Plant growth regulators may be added to FolrFeed® Alfalfa Foliar to improve branching, producing finer stem material, and expand leaf area for greater nutritional value.

HANDLING AND STORAGE

FolrFeed® Alfalfa Foliar is a mildly corrosive liquid fertilizer and should be handled and used in accordance with state, local and federal regulations where applicable. Materials and methods of construction selected for storage and handling should be those recommended by qualified manufacturers, associations or recognized testing laboratories. Type 304 or 316 stainless steel, polyolefins, fiberglass, reinforced plastics, polyvinyl chloride, polypropylene, polyethylene-applied coatings and rubber linings are generally suitable for storage and handling of mixed liquids. Mild steel is acceptable if cleaned after seasonal use and is used to store materials less than three months (cumulative) annually. Aluminum, brass, copper, zinc and many alloys, especially those of copper base, are unsuitable for use in storing and handling mixed liquid fertilizers and must be avoided. Rinse and flush thoroughly before retiring equipment for the season.
