## GENERAL INFORMATION

PCT | Sunrise NutraBurst<sup>™</sup> MicroMix is a liquid dual-chelated micronutrient fertilizer solution with boric acid, Copper, Manganese, and Zinc. Micronutrient deficiencies typically occur when plants are young, therefore, it is recommended to add NutraBurst<sup>™</sup> MicroMix at or before planting. Use in 2x2 application at planting or in foliar applications according to crop needs at key development stages. Consult with your agronomist and use a tissue test to confirm rates.

## HAZARD STATEMENTS:

Causes eye irritation. Harmful if contact with skin. Harmful if swallowed. Harmful if inhaled. May cause respiratory irritation. Suspected of damaging fertility or the unborn child.

PCT | Sunrise NutraBurst<sup>™</sup> MicroMix is a mildly corrosive liquid fertilizer and should be handled and used in accordance with state, local and federal regulations where applicable. Materials and methods of construction selected for storage and handling should be those recommended by qualified manufacturers, associations, or recognized testing laboratories. Type 304 or 316 stainless steel, polyolefins, fiberglass, reinforced plastics, polyvinyl chloride, polypropylene, polyethylene-applied coatings and rubber linings are generally suitable for storage and handling of mixed liquids. Aluminum, brass, copper, zinc and many alloys, especially those of copper base, are unsuitable for use in storing and handling mixed liquid fertilizers and must be avoided. Rinse and flush thoroughly before retiring equipment for the season.
