RECOMMENDATIONS FOR USE

Use with corn or soybean in-furrow or 2x2 application at planting, or in foliar applications according to crop needs at key development stages. Typical application rates are 4-8 oz/ac at planting, 7-14 oz/ac foliar in corn or 16-32 oz/ac foliar in soybean. Consult with your agronomist and use a tissue test to confirm final foliar rates. PCT | Sunrise NutraBurst™ Manganese 5% may be tank-mixed with most herbicides, fungicides, or insecticides, although a jar test is recommended. When applying to foliage, total spray volume of 10-15 gal/ac is recommended for best coverage. Do not apply if air temperature exceeds 85° F or in noonday sun.

GENERAL INFORMATION

PCT | Sunrise NutraBurst™ Manganese 5% is a liquid fertilizer with manganese and EDTA, designed to maintain rapid vegetative growth in adverse growing conditions or soils naturally low in that nutrient. PCT | Sunrise NutraBurst™ Manganese 5% helps break seed dormancy, supports chlorophyll development and catalyzes the activity of key plant enzymes.

HAZARD STATEMENTS:

PCT | Sunrise NutraBurst™ Manganese 5% is a mildly corrosive liquid fertilizer and should be handled and used in accordance with state, local and federal regulations where applicable. Materials and methods of construction selected for storage and handling should be those recommended by qualified manufacturers, associations, or recognized testing laboratories. Type 304 or 316 stainless steel, polyolefins, fiberglass, reinforced plastics, polyvinyl chloride, polypropylene, polyethylene-applied coatings and rubber linings are generally suitable for storage and handling of mixed liquids. Aluminum, brass, copper, zinc and many alloys, especially those of copper base, are unsuitable for use in storing and handling mixed liquid fertilizers and must be avoided. Rinse and flush thoroughly before retiring equipment for the season.
